

MILKABLE COW AND TRAILER DISPLAY

PLEASE NOTE: The Milkable Cow will be delivered, set up and picked up by a representative of the Florida Federation of Fairs. Reserving early is the key to having this program work. The person in charge of the exhibit at your fair must be available when delivery and pick up are scheduled.

This exhibit is very popular, especially with the addition of the self-contained trailer for hauling and display purposes and it is a GREAT way to educate the public about agriculture.

Fairs who did not have the exhibit last year will be accepted first on a first-come basis. If there are no applications from these Fairs, then the cow will be available to those Fairs who had it last year on a first-come basis.

Make your check for \$1,000. (\$250. fee and \$750 refundable damage deposit) payable to Florida Federation of Fairs and mail to Lisa Hinton, Florida Federation of Fairs, 12802 Balm Boyette Road, Riverview, FL 33579.

For exhibiting the trailer, you will need:

- 40 foot exhibit area
- 12 foot depth
- A 110 outlet – 30 am plug adaptor. The trailer comes with a 20' cord, any extension must be heavy duty.
- A check will be done when trailer is picked up and any damage is the responsibility of the Fair.
- Exhibit must be accessible to truck when pick up is scheduled.

The Florida Federation of Fairs is providing a program whereby Florida Fairs can borrow a mechanical/milkable cow for use during their Fair. This cow is life-size and simulates a real “milking experience” and is housed in a 12’ x 32’ display trailer.

It is the intent of Dairy Farmers Inc. that this cow be incorporated into an educational display about the Dairy Industry. Signage and display items are included in the trailer that show how much feed, hay and water a cow eats in a day and how much milk a cow produces in a day. It is suggested that some type of hands-on activity with a dairy product be conducted in cooperation with the milkable cow.

The Cow is available for Loan per the following provisions:

- Applications for reserving the Milkable Cow will be mailed sometime during August/September each year.
- Applications with request for dates must be sent to Jeanne Keaton, St. Lucie County Fair, P.O. Box 12478, Ft. Pierce, FL 34979 or fax to 772-464-8892 or email to jeannek@stluciecountyfair.org. Check for \$1000. (\$250. rental fee and \$750. damage deposit) should be **payable to Florida Federation of Fairs** and mailed to Lisa Hinton, Florida Federation of Fairs, 12802 Balm Boyette Road, Riverview, FL 33579. Applications will not be accepted without \$1000. check. Once your request is processed refunds will not be made because other Fairs will be denied use of the cow for that time-frame.
- Fairs that did not have the exhibit last year will be accepted first come basis. If there are no applications from these Fairs, then the cow will be available to those Fairs who had it last year on a first come basis.
- Applicants will be notified as to whether or not their application has been accepted based on the availability of the cow. If cow is not available, entire fee/deposit will be returned.
- Once application has been confirmed that the cow is available, the Fair must present: 1.) a Certificate of Insurance naming the Florida Federation of Fairs as additional insured for \$1 million in liability. Insurance agreement must be mailed to Jeanne Keaton (address above) 2 weeks prior to the opening of the Fair; 2.). The trailer cannot be released without a copy of this insurance coverage.
- The person that is primarily responsible for the operation of the cow during the Fair must be present when the cow is delivered so that they can be trained on the proper operation and maintenance of the cow.
- The Cow is housed in a self-contained “display” trailer.
- If signs or display items are lost or damaged, the borrowing fair will be responsible for the replacement costs.
