Two (2) *Farmer For A Day* and Two (2) *Milk Maker* exhibits are available.

The Farmer for a Day activity station is an engaging, entertaining, educating way to provide families with young children an opportunity to make memories at your fair. Playing together at the Farmer for a Day station, families learn that there is something (a farm) before the grocery store. The station includes the following activities, finding eggs nestled in the straw, plucking a shiny orange or grapefruit of a tree, and digging for that perfect potato.

The Milk-Maker activity station allows visitors to actually squeeze milk out of a life-like cow, complete with udder and teats. Milking into a bucket, allows fairgoers to gain a real understanding of where milk comes from.

A check for \$150 (\$50 fee and \$100 damage deposit) **for each exhibit** should be payable to Florida Federation of Fairs and mailed to Lisa Hinton, Florida Federation of Fairs, 12802 Balm Boyette Road, Riverview, FL 33579.
- All applications must be received by the deadline and then then assignments will be made. Those not able to receive the exhibits the previous year will be given first priority.
- If exhibits are not available fee and deposit will be returned
- The borrowing fair will be responsible for the shipping fee to the next fair or location.
- A checklist will be provided with each exhibit. It is the responsibility of the shipping fair to make sure ALL items are in the box.
- Upon arrival it is the responsibility of the receiving fair to check the items in the box and fax the checklist to Jeanne Keaton. It is the only way to insure that the proper fair is charged if items are missing.
- The fair responsible will be charged for the missing items
