Moreover, Exhibitor agrees to release, defend, indemnify and hold harmless the Florida Federation of Fairs & Livestock Shows, Inc., its officers, directors, agents and employees from any and all damages including but not limited to bodily injury (including death), liabilities, or charges resulting from Exhibitor’s use or appearance on or around the Resort. Exhibitor’s release, defense, indemnification and hold harmless shall include all losses, costs, damages or expenses arising from or out of or by reason of any accident, property loss, bodily injury (including death), or other such occurrences to any person or persons, including the Exhibitor, its agents, employees, and business invites which arise from or out of the Exhibitor’s occupancy and use of the Resort.

Exhibitor shall obtain and keep in force during the term of the installation and use of the exhibit premises, policies of Comprehensive General Liability Insurance in this Exhibit Agreement, in an amount not less than \$1,000,000 Combined Single Limit for personal injury and property damage. The Florida Federation of Fairs & Livestock Shows, Inc., its officers, directors and agents, The Resort, its owners, its operator, shall be included in such policies as additional named insured’s. In addition, Exhibitor acknowledges that neither the Florida Federation of Fairs & Livestock Shows, Inc., the Resort, its owners, or its operator, maintain insurance covering exhibitor's property and that it is the sole responsibility of Exhibitor to obtain business interruption and property damage insurance insuring any losses by Exhibitor.
